Motions proposed for amendments to the Constitution:

- Proposed by Gareth Thomas / John Deaton: Replace paragraph 1 with: 'The area covered by the Association (referred to henceforth in this document as 'the County') shall consist of the Unitary Authorities of :- South Gloucestershire, Bristol, North Somerset and Bath & North East Somerset.'
- 2. Proposed by John Deaton: in paragraph 4h replace 'meritous' with 'meritorious'.
- 3. Proposed by Gareth Thomas / John Deaton: Replace paragraph 10 with: 'In the event that the liabilities of the Association exceed its assets, the Trustees shall be requested to administrate all matters. The Trustees will immediately ensure that every reasonable effort is made to obtain grant aid or financial support at this time. However ultimately each club affiliated to the Association, at this time, shall be liable to pay to the Association a percentage of the any remaining shortfall. The percentage shall be calculated according to the membership of each current Affiliated club registered at a time most recently before the date of this event'

All three motions accepted unanimously.

Motion from the Management Committee:

'That the document circulated with the Provisional AGM Agenda (with whichever of the above items the meeting sees fit to accept) is accepted as the current Constitution of the Avon Athletic Association'.

Accepted unanimously. The Secretary was authorised to produce a re-formatted version of the Constitution incorporating the above amendments.
